Also whether or not any member of Narcotics Anonymous in the Ohio Region can see our insurance policy? I will be more than happy to share One Hundred and Twenty-seven pages of the two insurance policies that we have in effect that I have been scouring over these past few weeks. That are required because we are a Not-for-profit organization and I was preparing for any questions they may come as a result of what was just stated. Just to be clear, numerous phone calls and emails with the insurance company and actual members of the administrative body transpired before we were offered and purchased our insurance. It was totally conveyed to the company what the Ohio Region of Narcotics Anonymous is, as well as what the fellowship of Narcotics Anonymous is as a whole. The insurance company is well aware of our website, functions, and meetings that happen throughout the state of Ohio. COASCNA (Central Ohio Area):

Hello Family,

Let me preface this report by saying that due to the COVID crisis the Central Ohio ASC did not meet in March and our April meeting is scheduled to be held virtually on April 19. The Central Ohio Area serves: Franklin, Delaware, Union, Fairfield, Pickaway, Madison and Licking counties

- At our last ASC meeting, 21 groups were represented, and since then 2 new groups have been started in our area.
- Vacant area trusted servant positions: RCMA, Activities Chair, Unity Day Ad Hoc Chair
- We recently passed a motion to post ASC meeting minutes on our website (removing trusted servant contact info)
- I have not had an opportunity to connect with our treasurer so I don't have current donation information available.

As of April 8, there are 45 virtual meetings happening locally per week, utilizing the Zoom platform. I have attached a PDF of all meetings to this report. Ironically, after the discussion we had at the last regional meeting around using Zoom, our area discussed and had made plans to offer Zoom to participants attending our March ASC meeting. Unfortunately, our March meeting never took place but most of us have had the opportunity to learn and use Zoom on the fly anyway. Look how God works!

Area Convention: The Feb report listed 36 basic and 54 full registrations already sold. COACNA 29 will be held at the Marriott by the Airport on January 14 - 16, 2022. Room rate is \$92/night and there is a website www.COACNA29.org/

Area Office: Before COVID the office was open 6 days a week, Mon-Sat and were looking to add people to the Rides to Recovery & Clean Connections programs. In Feb. they reported 112 phone calls and 7 newcomer calls.

H&I Subcommittee: In March H&I reported 17 active commitments being filled and 1 new commitment on hold while they hire new staff. The H&I *Jail Break & Pancake Breakfast Fundraiser* was held on March 7 and was a great success that raised \$1,400. Proceeds of the fundraiser goes toward beefing up our H&I literature inventory. Of course, due to the shelter in place order and the restrictions on visitors for most facilities, none of our current commitments are being fulfilled. This time more than ever facilities are requesting literature for their clients, especially since we aren't able to go in. We were able to place a large literature order with the WSO right before the shelter in place order came down. So now we can provide literature to any facilities that need it. The Better Late Than Never group's annual Spaghetti Sling (which is a fundraiser for H&I) was originally scheduled for April 3rd has been postponed.

OCNA 38 Fundraiser: This event was originally scheduled for last weekend April 4 but was canceled due to COVID concerns. Our area will most likely donate to OCNA instead. This will be decided at our area meeting next week.

Public Relations Subcommittee: The PR subcommittee has been working diligently on getting the word out about virtual meetings. Central Ohio groups have moved to the virtual platform, and as I stated earlier, we currently have 45 meetings. The committee has been updating the nacentralohio.org website with a “virtual meetings” tab for easy access to meetings and links, as well as a “how to” virtual guide. Members are providing trainings for those who want to host and/or chair a meeting. COASCNA virtual meetings were discussed in an ABC6 News feature and in the Columbus Dispatch. The virtual schedule PDF was sent to several Central Ohio organizations to share with those who may need it.

OCNA AC I:

Following our last Regional meeting in January I was contacted by Joel S. of the Buckeye Region regarding OCNA 39 scheduled for 2021. We discussed the Ad Hoc Committee which had been formed to begin the process of scouting sites for the next Ohio Convention. I provided general information related to the size and type of host hotels as well as info about the planning timeline, attendance, fundraising and financial considerations. Using information that I received from other Advisory Committee members Charles F., Aaron R. and previous Convention Committees I began to prepare a packet to send to the Ad Hoc Committee to assist them in the bidding process. Soon after, Rodney C. Chairperson of OCNA 38 contacted me and expressed some concerns. One, that fundraising donations for the current Convention had slowed and two, the developing COVID 19 situation might require OCNA 38 to be postponed or cancelled. After contacting Charles and Aaron we decided to have Rodney revisit the contract with Kalahari to determine if the agreement could be cancelled or changed without penalty. They agreed. At the same time Joel S. polled people in the Buckeye Region about skipping this year but keeping the rotation for hosting OCNA the same. He reported that was the consensus. I drafted a motion to that effect and ran it by the OCNA AC members as well as our Executive Committee for input.
