of us this cycle and there are two initial recommendations for discussion. These ideas would be included in the 2023 CAR for Fellowship decision.

First recommendation is trying a three-year conference cycle for two cycles—from 2023 to 2029. In February, the board talked about some of the possibilities in a three-year cycle and are excited about what that might look like yet know, business as usual is not sustainable.

Second recommendation is that delegate funding be available to any participant upon request. Currently World Services automatically funds all seated delegates. An increasing number of participants have chosen to opt out and fund their own delegates. It is being suggested switching from an "opt-out" system to an "opt-in" one and funding would be available for the delegate of any seated participant without question.

Attracting members to service seems to be a never-ending topic that's never out of season. Many service bodies have begun meeting in person after not doing so for months and participation has dropped off in many places.

On 19 March, we were able to hear from members around the world about what's working for their groups and service bodies. There was Spanish and Portuguese interpretation, and a webinar was streamed on YouTube in English. As you can see, information is disseminated in various forms that all members have an opportunity to participate. So, if you have any innovations or new approaches to getting members involved in service, please let it be known.

Revising The Loner IP

Work has begun on a project passed at the last World Service Conference to revise IP #21: The Loner, Staying Clean in Isolation. The world has changed a lot since The Loner was written in 1986, and the IP is outdated.

Please note, all NA literature projects begin by asking the Fellowship what to include or focus on in the piece of literature. There is a survey posted (www.na.org/survey) for fellowship involvement and workshop materials on that same page so that you can discuss ideas with your group or service body.

What do you think should be changed in the IP? All members are encouraged to fill out the survey, which will be posted until the end of August 2022. If you have pre-pandemic experience recovering as a loner, we are particularly interested in hearing from you.

BLASCNA (Best Little Area): Present (Zoom), No report

COASCNA (Central Ohio Area):

Hello everyone, my name is Tracy and I'm the RCM for the COASCNA region.

We are currently representing the Delaware, Franklin, Madison, and Union Counties

We currently are operating 23 in-person meetings and 10 Virtual meetings

Established meetings are reopening and new meetings are starting up as COVID numbers decline. These meetings may be meeting in different locations and at different times. As we no longer publish a schedule, it is difficult for our members to know where and when these meeting are. We can always point them to our website, but we can also spare a moment to tell them about a meeting. We currently are hosting number of meetings.

Our Area office has been getting a new spark of energy as an influx of letters coming from jails and Institutions from all over Ohio! There has been an overwhelming number of addicts behind the walls seeking recovery and sponsorship. Also, we feel that the momentum is building to soon be returning to all facilities in the next few months. We are reestablishing connections with our 23 commitments and adding a new commitment this month at Ohio Addiction and Recovery. We are continuing to partner with Public Relations to create zoom recording speaker videos to be distributed to iPad in the Ohio prison system. Next month I will provide a detailed report on the videos created and the status of each. *Had meetings with trusted servants in Florida and Alabama to share best practices and lessons learned when working with prison officials to provide free NA resources on the computer tablets of the incarcerated in their respective states; responded to requests from PR trusted servants in the Plain States Zone of NA to share information about it on prison tablets • In collaboration with WSR (Writing Steps for Recovery subcommittee), information on how to get paired with an NA member who will serve as a step guide was pushed out to the computer tablets of those incarcerated in the ODRC (Ohio Department of Rehabilitation and Correction). To date nearly 70 letters from incarcerated Ohioans have been received. • Started working with COASCNA H&I subcommittee in September 2021; sent the Chair a video from the United Kingdom's NA Fellowship that is getting shown on prison monitors there. Discussed with the Chair the possibility of H&I here doing the same thing. H&I committee members watched the UK video and discussed the possibility in October. In November I attended the H&I subcommittee meeting to help brainstorm what a video could look like (duration of video, how it could get pushed to the tablets, timeline, etc.). I contacted the H&I Chair who said that a video is ready, and that more are planned. We will work together to get these pushed out to tablets. o UPDATE: Video received from H&I Chair, and forwarded to the ODRC (Ohio Department of Rehabilitation and Correction) for review, who says that it should be fine, but they will need to get confirmation from OHMAS (Ohio Department of Mental Health and Addiction Services). • This month we would like to highlight one commitment that is in need of members to participate and help carry the message. I am requesting that GSRs specifically announce the following at their business meetings (and I have emailed this report to the secretary so you'll have all the details in the minutes): *Delaware County Jail -we are looking for men and women to go in separately -members needs to submit paperwork and receive training by the facility to

be cleared -to be cleared, members need to be one year clean, one year free from probation, incarcerations, and interactions with law enforcement -the meeting would take place weekly so we would need a regular commitment - probably on a Friday or Saturday *this is a commitment we used to meet prior to the pandemic and we would like to get it going again - please spread the word to all members / but especially those who may be geographically closer to Delaware and meet the requirements -again interested members should attend our April subcommittee meeting and/or reach out before then to start the clarence process Our H&I auction event/fundraiser was a huge success. Thank you to the members who donated, attended, shared,

The PR committee 02/07/2022 presented to 8 fourth-year medical students at The Ohio State University. These students will soon be practicing physician residents in our communities. An event tentatively called "Predecessors Day" in the summer of 2022. Planning is in early stages.

WSR Committee: So far, we have received 94 letters. 63 from men and 31 from women. We are currently reviewing and refining our original processes to accommodate how our information went out and be able to serve the addicts that are writing to us in the best ways possible. Our biggest need is Step Guides. Please join us in inviting new Step Guides by announcing at every meeting and function you attend and reaching out to any and every one in your contact list that we are looking for people who are willing to work steps by mail with incarcerated addicts seeking recovery. Simple go online at the area website under the WSR tab and fill out the application to begin the process. Feel free to reach out to us by email or to any of our members with listed phone numbers. We are happy to answer further questions. Or simply stop by our meeting, which is the second Thursday of the month on zoom at 5:30



Figure 3 **Type of Contact 1/1/2022 to 1/31/2022** (as of 2/8/2022)





Figure 4 Area Contact 1/1/2022 to 1/31/2022 (as of 2/8/2022)

Figure 5 **Type of Contact 2/1/2022 to 2/28/2022** (as of 3/7/2022)





Figure 6 Area Contact 2/1/2022 to 2/28/2022 (as of 3/7/2022)
