Hello Family,

It is a pleasure and honor to be of service to the HAMASCNA area and the Ohio Region, My name is Ryan A. and I'm an addict. Our Regional Committee Member Team consists of myself and Mack M.

The geographic area served by the H.A.M.A.S.C.N.A Area is Butler & Warren counties. Our area presently has 21 groups and 21 meetings. H&I is visiting 4 treatment centers throughout the week. At our last Area Service Committee meeting, 9 GSR's were present. In the past three months one meeting has moved locations, and our newest meeting (Without Parallel) has still been struggling with attendance. In the past three months, 1 group has folded, and another long standing meeting has talked of closing the doors by the end of the month (Serenity on South 2nd Street).

Monthly expenses for the HAMASCNA Area at our last ASC meeting were **\$194.81** . Total donations from groups to the Area were **\$178.00**, and Activities gave back to the area a total of **\$1236.75**. We are making a donation in the amount of **\$67.62** to the Ohio Region this quarter. The income has remained stable, albeit with generally low contributions from the Homegroups. Our Activities events generate a significant return to our area.

At present, our area does not have a designated literature distribution chairperson or vice chairperson. Instead, we have collaborated as an area service committee to order and distribute literature to the HAMANA Homegroups. Generally, we source literature from the World Service Office; however, some groups have opted to acquire their literature from alternative sources. The distribution of literature, H&I, and lack of Homegroup participation appears to be the most significant challenges we are currently facing as an area.

There remain several vacant service positions, including P.R., Lit. and V. Literature Distribution, Policy Administration, V. Secretary and V. Webmaster. As reported earlier, we still struggle with Literature Distribution, but we are hopeful that someone step up to the position soon, and our H&I seems to have been "forgotten about", lacking any structure (ie: SubCommittee meetings, etc.). I have recently taken the responsibility of a Panel Chairperson at a local Treatment center and am motivated to take on more responsibility to help strengthen our H&I Sub-Committee. Since our last Regional meeting, we have elected Justin B. (Our area V. Chairperson) as the next term's Serenity In the Woods Chairperson, who is excited to move forward with planning this years Annual Campout Convention.

Our area is registered as a Corporation for Nonprofit. We meet at 2910 Central Avenue Middletown, Ohio the third Sunday of every month at 12:00pm. Our area has a separate Activities Subcommittee and Serenity in the Woods Subcommittee, which hosts several events year round and our annual Campout Convention. Our upcoming events are:
