Hello family, it's hard to believe April is here already.

Last quarter there was a focus on CAR motions and RCM'S was encouraged to Zoom in on the Mid-West Zonal Forum, Southeast Zonal Forum, or the Plain States Zonal Forum as they shopped the CAR/CAT with World Board participation. This effort was to insure RCM'S had enough time to get the information back to Areas and Groups. We will tally all votes today.

On March 25th Charles & Kirby hosted a CAR/CAT workshop with very little participation. We are all aware of how difficult it is to attract others into service.

Interestingly, on March 18th Steve R (NAWS) sent the following:

Hello.

I am from the Miami Valley Area Service Committee of Narcotics Anonymous. We serve Miami, Logan, Shelby and Darke Counties of Ohio. I'm currently the Public Relations Chair.

Our Area currently has the following open positions: Area Chair, Area Secretary and RCM, H&I Vice Chair, (our Treasurer was trying to step down but we convinced him of taking another term)... you get the idea. We have no Trusted Servants at the Area level aside from the Subcommittees and Treasurer. Glad to be back at another regional meeting. I missed you all in January!

Here are some other things that were completed over the last quarter:

- I worked with Jessica G. from the Buckeye Region who is now their regional BMLT contact. I helped her with creating a new BMLT-driven meeting page for their new website. I also helped her resolve some issues she was having with WordPress.
- I created a new Spring Retreat website for their online registration. They originally decided to use Venmo, but it has fees similar to PayPal if it's a business account so they switched back to using PayPal for their payments.
