Hello family, my name is Tom, and I am an addict. Currently the RCM for the BLASCNA area.

The BLASCNA area is doing well and surviving on group 7<sup>th</sup> Tradition donations. We currently have 26 meetings in Lucas County and 2 in Fulton County. Two meetings continue as hybrid, live and on Zoom. One new meeting started in the last three months and one closed. We've recently had 13 to 18 groups represented at our monthly ASC meeting held at 565 Palmwood, the first Saturday of each month. Because of a TACNA 26 fundraiser last weekend our area service committee is meeting today, so I was unable to get the quarterly regional donation from the treasurer. I will ask him to mail the donation or provide two in July.

Currently, our area needs a vice-chair, a vice-treasurer, an alt RCM, a PR chair and an Outreach chair. H&I hosts meetings in 3 facilities weekly. Phonelines continues to get 3 to 7 calls each week along with a dozen spam calls. Our Activities subcommittee is working at having an event next month. TACNA 26 had a Sponsorship Gala Banquet last Saturday which was well attended by over 150 members. A one-of-a-kind NA tee shirt was auctioned off for \$811.00

We purchase monthly about \$600 to \$1500 worth of literature from either the Michigan Regional Service Office or NAWS. Currently the ASC bank balance is at \$7,742.15.

## **HAMASCNA** report:

Hello Family,

It is both a pleasure and an honor to serve the HAMASCNA area and the Ohio Region. My name is Ryan A., and I am an addict. Our Regional Committee Member Team includes myself and Mack M.

The H.A.M.A.S.C.N.A Area covers Butler and Warren counties. Currently, we have 16 groups and host 16 meetings. Our Hospitals and Institutions (H&I) committee visits four treatment centers each week and plans to begin outreach to two additional facilities in the near future. During our last Area Service Committee meeting, we had nine Group Service Representatives (GSRs) in attendance. Over the past three months, one meeting has relocated, and our newest meeting, Without Parallel, continues to face challenges with attendance. Additionally, one group has folded during this period.

In terms of finances, our quarterly expenses for the HAMASCNA Area were \$3,698.72, while our total income for the quarter was \$3,387.00, resulting in a net loss of \$311.00. Donations from groups to the Area totaled \$634.30, and our Activities committee contributed \$202.00 back to the area. We will be making a donation of \$48.93 to the Ohio Region this quarter. Overall, our income has remained steady, with increased contributions from Homegroups compared to previous periods, although our Activities events generated significantly less income than last quarter.

Currently, we do not have a designated literature distribution chairperson, but we have elected a vice chairperson. As an area service committee, we have worked together to order and distribute literature to the HAMANA Homegroups. While we typically source literature from the World Service Office, some groups have chosen to obtain their materials from other sources. The distribution of literature, H&I efforts, and the lack of participation from Homegroups are the primary challenges we are facing at this time.

Several service positions remain unfilled, including Public Relations, Literature, Policy Administration, and Vice Secretary. As mentioned in the previous quarter, we have faced challenges with H&I engagement and organization over the past year, lacking any clear structure. However, I have recently taken on the role of H&I Chairperson and held a productive Subcommittee meeting last month with around 15 participants. During this meeting, we elected a Vice Chairperson, Secretary, Vice Secretary, and panel chairs. I have been in touch with the Butler County Jail and The Hope House (a shelter and treatment center for men and women), focusing on rebuilding our relationship with the Women's Jail. This effort includes getting female panel members approved and oriented before we return to regular H&I meetings. Progress is being made, and the outlook is promising in this area.

Justin B. has adapted well to his new position as Chairperson for Serenity in the Woods. Although the planning for this summer's campout started later than preferred, the subcommittee meetings are showing potential. They recently held their first fundraiser, the Staying Green in Recovery Speaker Jam, which attracted a good turnout and generated a profit of \$631.31. I have also brought Staying Green in Recovery shirts to sell for \$20.00 each.

Overall, things are looking up. We are excited to host OCNA and have dedicated significant effort to ensure a successful event while maintaining our momentum. Looking ahead, we have our area Cookout in June, where we will elect trusted servants for the upcoming year, OCNA in May, and our annual campout in September. After that, it's just a cycle of Wash, Rinse & Repeat for our area.

Our area is registered as a Nonprofit Corporation. We meet at 2910 Central Avenue, Middletown, Ohio, on the third Sunday of every month at 12:00 PM. Additionally, we have a separate Activities Subcommittee and Serenity in the Woods Subcommittee that organize various events throughout the year, including our annual Campout Convention.

Also tradition 11 that we need always maintain personal anonymity at the level of press radio and films. Raises the question of adjustments to these readings and personal preferance.

## **MVASCNA** report:

We currently have 1 H&I panel going into Miami county jail every week, rotating the men and women on opposite weeks. My January report contained a bit of concern that Townhall had not received our contract because of lack of communication from them. However, since then everything has leveled out – as much as it can. Like every other public service organization, Townhall has been deeply affected by recent budget cuts. We have changed contact people twice in these last few months. It seems that our most recent contact person may be in this position for a while, and she is working to learn what we need from her and from her agency.

Although I did send Townhall an updated list of our member Areas and their associated communities, that list did not get incorporated into this quarter's report. She apologized for that an assured the update will be made prior to our July meeting.

There is a new format for the report Townhall submits to us. Rather than breaking calls out on a month-by-month basis, the new format incorporates the data into a single, collective quarterly report. I don't see any problem with this. If anyone believes this is problematic, please let me know, and I will ask Townhall to revert to giving us month-by-month numbers.

The number of calls received was up just slightly. Last quarter we received 102 calls; this quarter we received 115. By far, the largest category of calls was for "other," which I have learned is Townhall's grouping for callers who request resources other than NA meetings, or calls where a caller is in crisis and needs to talk. Our phoneline received 35 such calls this quarter.

That was followed by calls about COASCNA (20), Finally Free and HAMASCNA (8), and Springfield, Scioto Valley, and the Buckeye Region (6). All other areas received 4 or fewer inquiries.
