Happy New Year everyone, the time has come to prepare for the World Service Conference 2023 themed “Creating Our Future” will be held April 30 – May 6.

As we all know, the pandemic changed all the NA fellowship and so did the priority of what was needed. Virtual Meeting Basics is an example of a priority established by the WSC despite the conference’s previous decision to prioritize FD Basics. It is expected this survey will help all of us to understand what our members and service bodies would most like to see worked on.

In keeping with the theme for the cycle, we are truly all Creating our Future. The hope is, that members will participate and encourage other members to do the same.

This is the fourth time a survey has been included in the Conference Agenda Report to help set priorities for recovery literature, service material, and Issue Discussion Topics (IDTs). The results of this survey will help delegates select Issue Discussion Topics and prioritize IPs and service material to work on in the cycle ahead.

At each conference, the results will be compiled from members and from conference participants—seated regions and zones. Those results are distributed at the conference and included as an appendix in the minutes.

It is asked that all members fill in the online survey posted at www.na.org/surveys by April 1, 2023, and those responses will be compiled for the conference to consider. We are also asking conference participants to collect the conscience of their service bodies by the same date. We will compile those results to distribute as well.

Four of the items in this survey come from motions the WSC has already approved to create project plans,

Unless otherwise directed by WSC 2023, the WB is planning to work on finalizing revisions to The Loner IP, which was a project passed in 2020. Members were clear in their responses to the Loner survey about what they would like to see changed or included.

The geographical area served by the MEASCNA Area is Licking, Fairfield, Muskingum, Guernsey, Coshocton, Perry, and Knox counties. Our area presently has 24 groups, 43 weekly meetings, and 3 H&I panels. At our last Area

Service Committee meeting, 13 groups service representatives were present.

The area service meeting is held on the first Monday of each month at 6:30pm at the Faith United Methodist

Church located at 261 East Main Street Newark, OH.

Good morning. STASCNA is the Stark, Tuscarawas & Carroll County area. We have meetings in 5 counties, including those already mentioned, as well as Wayne and Summit Counties. As an area, we continue to struggle. We lost another meeting during this past cycle. The Friday Night on E High meeting in New Philadelphia has shut down. We now have no meetings anywhere in our area on Friday night. As of this time, we have 19 weekly meetings, including one virtual meeting.

We have several open positions at the area level. Our H&I chair has been vacant for several months now. We have only one H&I meeting going – it's a men's presentation at a correctional facility on Fridays at 10:30 a.m. Our PR chair has been vacant for a few months. RCM-Alt has been vacant for years. Our literature chair finished his 2nd term last month, and that position is now vacant. After being vacant since October, the RCM position has been filled again. I am pleased to be of service in that role.

We have a new person in the role of activities chair who seems to have some great ideas. He hosted a Glazed & Confused function in December, which was a hot chocolate and pottery painting event. It raised a few hundred dollars and was enjoyed by those who attended.

We have formed an ad-hoc committee to explore our area's technology needs. We have a hybrid area meeting, but the laptop that has been used belongs to a member. Consistent connection has been a challenge, so this ad-hoc's primary task is to determine how much we would need to spend to adequately host the hybrid meeting. As we cover such a large geographic area, many members feel this is important. This same ad-hoc committee will explore the possibility of our area creating a technology chair position. Some initial thoughts for this position will be to set up the equipment for the hybrid ASC meeting and maintain the area website.

Our area Treasurer would like to know if ORSCNA ever received the check she mailed in September. Apparently, she sent it to the wrong address, but the recipient was supposed to forward it. If it has not been received at this point, she is going to cancel the check.

12-step Chair Report

1-14-2023

Hello family, it's a great day to be clean! I hope everyone is staying warm and had a wonderful holiday season. It has been an honor to serve as the 12-step retreat chair for this year. The event was a complete success as the message was carried to the addict who still suffered, and the event was a rousing success thanks to the wonderful committee that I had in place! I can't, but we can!

Due to inflation and the rising costs of all goods and services, some of our projections came up short of what we hoped for a return donation to the region, but again, the primary purpose of the event is carrying the message, not making money. The final balance for our 12-step ledger was \$2439.02, meaning we were a positive \$639.02 over our starting prudent reserve of \$1800. At this point we have not wrote a check for this to return to the region, dependent on the pending vote today of increasing our prudent reserve to \$3800 to have funds in place for needed services early next year and to avoid all bank fees for balance below \$3500. We will still be over \$1000 below that needed threshold to avoid bank fees, but we will be closer.

We had to write a check this past week to Mark Roberts for covering a \$115 check debt to PayPal from a check that did not clear from an addict who paid for registration. We are currently investigating it as the addict whose name is attached says she never made the reservation, but I found two names affiliated with the reservation and PayPal payment, so we are currently investigating through registration in order to approach the correct addict in order to try and recoup the funds for the retreat.

I cannot thank this body, the fellowship, and my committee enough for the understanding of my need to be with my teenage daughter over the weekend of the retreat as she gave birth to my newest, healthy granddaughter on Saturday of the retreat! Once all was confirmed that mom and baby was healthy and happy, my daughter smiled and told me to get to Tar Hallow and I made it back just as the main speaker started! The baby is healthy and happy, and my daughter will receive her 1-year clean token here in a couple weeks – life is great! I will continue to be of service to the region in the future however I may according to this body's needs.

These funds are a deposit against the food and beverage total of \$15,000 required by the hotel. If the convention hits 15k in food and beverage, the deposit gets refunded.

January 2023**

Hello Family I'm TJ and I am an addict:

I'm grateful to be clean and of service to the Ohio Region. We began our quarterly business meeting with \$17,009.51 in the bank. Business on Saturday produced donations totaling \$16,223.85 and a return of funds of 150.00. In addition, we paid expenses totaling \$1,308.85. This left us with an ending balance of \$32,074.46 prior to the World Services and MZF donations. Policy dictates we donate 10% of the end of Saturday balance to World Services and 5% to the MZF. Those donations were \$3,207.45 to NAWS and \$1,603.72 to MZF. Our final balance at the end of the day on Saturday was \$27,263.29.

Sunday began with a balance of \$27,263.29. Expenses for Sunday totaled \$10,394.36. In addition, we received donations totaling \$772.60. This left us with an ending balance of \$17,641.53 at the end of business of Sunday. The weekend change in the balance of our account was a positive \$632.02. Unusual payments for the quarter included a \$4,000.00 loan to OCNA 39, repayment of the \$600.00 loan granted to Spring Retreat and payment of \$1,400.00 to Spring Retreat for prudent reserve. The enclosed income/expense statement shows a change of \$4,032.02. The difference between that number and the weekend change of \$632.02 is the repayment of the Spring Retreat loan and the granting of the OCNA 39 loan.

Included with this report you will find the Income/Expense Statement for the organization for the January 2023 meeting and one broken down by quarter for the last 12 months plus overall total during that period. You will also find a balance sheet, treasurer's worksheet, checkbook register and deposit total for the January 2023 meeting.
